Our Plan

To meet our commitment, Proman will:

- 2. **Prioritize** the prevention of work-related injuries, ill health, and unsafe conditions through hazard identification, risk assessment, and the implementation of effective controls using the hierarchy of control to eliminate hazards and reduce risks.

- 4. **Manage** all projects, processes and products through their life cycles in a way that **protects** safety and health, minimizes environmental impacts, conserves resources and promotes sustainable practices.
- 5. **Provide** employees and other stakeholders with the **capabilities**, **knowledge and resources** necessary to instill personal ownership and motivation to manage risk and achieve HSSE excellence.
- 6. **Measure, audit and publicly report** HSSE and performance and maintain open dialogue with stakeholder groups and with communities where we operate.
- 7. **Promote** participation, consultation, and active engagement with workers and stakeholders as part of our decision-making processes to achieve our HSSE objectives.
- 8. **Comply** with applicable laws, regulations and stakeholder requirements and **continually improve** our HSSE performance towards our goal of no accidents,
